



Subject to the provisions of any law relating to charities, the trustees shall cause accounts to be kept of all receipts and payments made on account of charity hereby constituted and shall make up such accounts for each financial year (i.e., April to March). The accounts shall be audited annually by a Chartered Accountant within the meaning of the Chartered Accountant Act, 1949 whom the Trustees may appoint and pay the remuneration for the purpose. The Trustees shall have the following powers subject however to the condition that they shall not use or apply income or property of the Trust directly or indirectly in terms of the section 13(1)(C) read with section 13(2), and 11 of the Income Tax Act, 1961 for the benefit of any person referred to in sub section 13 of the said act;
- To possess and manage the Trust estate and to do all acts, necessary for the maintenance, preservation and proper use and application thereof.
 - To open and maintain banking accounts of any kind or category in the name of the Trust or in the name of any or more of the Trustees with in Bank or Banks and deposit therein or withdraw there from any moneys and to operate upon the same to draw, issue negotiable and discount cheques, drafts, pay orders, promissory notes, and other bills of exchange. A Bank account may be opened and operated by the managing Trustee authorized in this behalf by the Board of Trustees, by a resolution adopted by a majority of not less than two third of all the Trustees for the time being.
 - To pay all taxes, and charges payable in respect of any immovable property for the time being forming part of the Trust Estate and to carry out necessary repairs and to keep the same insured against fire and other damages.
 - To lease any immovable property or properties for the time being and from time to time belonging to the Trust either from year to year or for any lesser term or for any term of years or on monthly tenancies, at such rent and subject to such covenants and terms as they may think proper and also generally manage the same in such manner as they think proper.
